COUNTY MANAGER'S MONTHLY REPORT



INTRODUCTION

The County Manager's Monthly Report provides updates on key programs and projects, County financials and metrics that help track how the staff are serving the community.

NOTE FROM THE COUNTY MANAGER

February came and went quickly with three Council meetings and a special joint meeting with the Los Alamos Public Schools Board to discuss the North Mesa Housing project.

- The Comprehensive Plan process kicked off, announcing open houses for the public and a survey to start the discussions.
- Members of the Los Alamos fire department were awarded the Phoenix award that honors exceptional teamwork, rapid response, and lifesaving actions that resulted in a patient's survival and full recovery.
- Wildland Fire Battalion Chief Van Leimer presented on the high-risk fire season anticipated for the 2026 spring/summer/fall seasons due to minimal moisture this winter and lack of snowpack.
- A task order was awarded to reconstruct Brewer Arena grandstand reconstruction including ADA upgrades, restrooms and other event support infrastructure.
- Councilors Cull, Hand and Reagor were assigned by Chair Ryti to a working group to review possible proposals to revise the County Charter.
- The County's finance and budget division were awarded the Government Finance Officers Association (GFOA) Triple Crown Honor in Awards for the FY2024 ACFR, FY2024 PAFR, and the NMC-OSC Audit Accountability Award for a mid-sized county due to their excellent high caliber work and standards they maintain for managing public monies.
- Firebrand was selected to support community climate marketing and engagement services and six new level 2 electric vehicle chargers located at the Municipal Building were completed as part of progress made on the County's Climate Action Plan.
- Municipal bonds were successfully sold to fund the community broadband project with construction starting this spring/summer.
- Gross Receipts Tax revenues are as projected at approximately 10% lower this year compared with last year.
- A new member was appointed to the Environmental Sustainability Board.

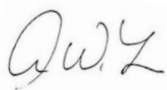
- February 3 – met with private developer regarding their LEDA application (former CB Fox Building)

- February 13 – had a phone call with DOE-EM Los Alamos Site Manager Jessica Kunkle to discuss the cancelled hexavalent chromium plume coordination meetings.
- February 13 – meeting with private developer of the CB Fox building to discuss security for their LEDA request
- February 18 – hosted a meeting with DOE-EM1 Tim Walsh and Council's federal working group members (Chair Ryti, Vice-Chair Herrmann, and Councilor Cull)
- February 19 – attended monthly meeting with LAPS, UNM-LA and Council leadership
- February 19 – attended monthly NM congressional delegation NM staff virtual meeting
- February 19 – met with a local Boards & Commission member regarding local issues of concern
- February 26 – attended a tour of the new Chamisa Elementary school prior to the joint LAPS/Council meeting
- February 28 – attended the Policed Department's annual award ceremony at Betty Ehart Senior Center

February concluded with meetings to finalize the fiscal year (FY) 2027 proposed budget. Overall, expect a slight increase in operational expenses due to salaries, benefits, contracts and a flat or decrease in other expenses. The proposed budget book will be published at the end of March with printed versions available for County Councilors by Friday April 3rd. Budget Hearings are scheduled for April 27, 28, and 29 – see you there!

Social Media Report

The County's main Facebook page reached 9,600 followers by the end of February, with 46% residing in Los Alamos and another 46% in the region. During February, there were 3,126 engagements on 118 posts.

The County's main Instagram account had more than 2,300 followers by the end of February, with 23.5% residing in Los Alamos, 8.8% in White Rock, and another 19.6% in the region. During February, there were nearly 10,000 views on 133 posts and stories.

INTERGOVERNMENTAL, TRIBAL, AND REGIONAL RELATIONS

State

The 2026 State Legislative Session ended on February 19. Major issues supported by LAC Council that passed included the Medical Malpractice Insurance Reform sponsored by Representative Chandler, enacting the Interstate Medical Licensure Compact as well as the Social Worker Instate Compact. Currently, the County has an allocation of \$1.152 million in Capital Outlay funding for housing infrastructure, although the bill has yet to be signed by the Governor.

Federal

The Federal Working Group (Councilors, Management and the Intergovernmental Affairs Manager) met with Mr. Tim Walsh, the new Assistant Secretary for Environmental Management at DOE along with other executives from DOE-EM. These conversations will help set discussion for the March advocacy visit to Washington, DC.

Chair Ryti, Councilor Reagor, and the Intergovernmental Manager (IA) attended the NACo Legislative Conference in Washington, DC, attending various workshops and educational sessions as well as policy committee meetings. The NM Counties Congressional Breakfast also allowed time for brief conversations with Senators Lujan and Heinrich.

Tribal and Regional

The MOUs with Espanola and Rio Arriba will be renewed in early March to allow Los Alamos County to continue supporting regional projects.

Conversations with the Pueblo of San Ildefonso on the hexavalent plume took place in January, and due to the situation, it was decided that further talks would take place further in the future.

Working with Pueblo of San Ildefonso on the Guaje Canyon road for emergencies and broadband continued.

FISCAL STEWARDSHIP

Budget: During the month budget finished meeting with all departments and imported all budgets into Munis. Meetings with County Manager's Office to compile and finalize budgets commenced and CIP meetings were finalized. Departments were instrumental in revamping a new look for the budget book with updated department summaries.

Finance: Los Alamos County Council recognized members of the Administrative Services Finance Division on Tuesday, February 17, 2026 for being awarded the Triple Crown Honor issued by the Government Finance Officers Association (GFOA), which recognizes governments who have received GFOA's Certificate of Achievement for Excellence in Financial Reporting for its Annual Comprehensive Financial Report (ACFR), Popular Annual Financial Reporting Award (PAFR), and the Distinguished Budget Presentation Award. This is the 34th year the Finance Division has achieved the ACFR award, the 33rd year achieving the Budget award, and the 10th year achieving the PAFR award.

EFFECTIVE, EFFICIENT, AND RELIABLE SERVICES

CLERK

Update

The Memorandum of Understanding (MOU) between the Los Alamos County Clerk's Office and the New Mexico Secretary of State's Office providing reimbursement for Primary Election expenses has been fully executed. This agreement allows the County to receive reimbursement for eligible costs associated with administering the state-funded Primary Election, helping ensure that election operations remain well supported while minimizing the financial impact on local taxpayers.

During the recent legislative session, the Clerk's Office was also actively engaged in monitoring election-related legislation and communicating with lawmakers and state partners regarding potential impacts to county election administration. In the final days of the session, two significant election bills were introduced with limited time for review and discussion. One of these measures, New Mexico Senate Bill 264, was ultimately approved by the Legislature and has been sent to the Governor for consideration but has not yet been signed into law.

Senate Bill 264 focuses on strengthening election security and continuity planning. Among its provisions, the legislation would prohibit unauthorized federal or military personnel from being stationed at polling places or near monitored ballot drop boxes during the election period. The bill also establishes additional guidance for emergency election procedures, providing a framework for the Secretary of State and county clerks to implement contingency measures when necessary. These measures could include relocating polling locations, adjusting voting sites, or utilizing alternative ballot delivery methods in response to emergencies such as natural disasters or other events that could disrupt normal election operations.

The Clerk's Office will continue to monitor the status of the legislation and review any new statutory requirements if the bill is signed into law. The office will also continue working closely with the Secretary of State's Office and other county clerks across the state to ensure any operational changes are implemented effectively. The goal remains to maintain secure, transparent, and accessible elections for all voters in Los Alamos County while ensuring full compliance with state law.

HUMAN RESOURCES

Updates

Human Resources interviewed for the Deputy HR Manager and Tania Echeverria de Lumas has accepted and will start on March 16, 2026.

Human Resources is still recruiting for the Senior Office Specialist.

HR is preparing for the upcoming FY27 Budget hearings.

The Personnel Board has two members whose terms will end on March 31st. One application was submitted and an interview was conducted in February. The Council Liaison will recommend the applicant for appointment to the Personnel Board and will be on the consent agenda for the March 3rd Council Meeting.

Risk Management is currently looking for a new OSHA compliance trainer.

Risk Management will be replacing existing AED machines in County Facilities.

Continued collaboration with the Training Manager as well with the ERP Manager on the implementation of the new annual employee evaluations in Munis / ESS.

Continued collaboration with the Budget team on Position Control for FY27.

Compensation launched the Job Description Review Project which is required every four (4) years.

Presented to SMT the Compensation piece to the revamped "Need To Know" presentation for supervisors.

Benefits conducted 10 retirement planning meetings in February.

Training Stats:

HR Training/Staff Development previewed the updated Manager Need to Know training for the Senior Management Team and plan to re-launch this important training in April 2026.

HR has redeveloped the Performance Planning Appraisal (PPA) system and process. The new system will be launched April 1st to be utilized for this PPA cycle. Several training sessions are planned in late March and early April to provide managers with system guidance.

New professional development courses, being offered in partnership with Santa Fe Community College, are available for registration in LAC University.

County employees are currently 93% compliant with required trainings, with 7% of assignments currently overdue.

Amendments to Chapter 16, Articles I and V of the Development Code are in the final stages of review and are being prepared for upcoming public hearings at Planning and Zoning Commission and County Council.

Infrastructure Update

The Group Policy Object (GPO) cleanup is now complete. GPOs are the behind-the-scenes settings that help manage how our county computers behave - things like security requirements, desktop configurations, and standard system settings.

Over time, these policies can accumulate and become difficult to manage, so cleanup helps ensure everything stays organized and efficient. By removing outdated policies and streamlining the structure, we now have a cleaner, more efficient environment. This refreshed setup also supports our ongoing Intune implementation, making it easier to manage devices consistently moving forward.

Thanks to Teo Ortega for leading this and to everyone who helped make this effort a success!

Application Update

Provided ongoing project support for Utilities on the Time of Use and Residential Demand software implementation; Municipal Court for the new Case Management Software implementation; Community Services for the new Recreation Reservation/Registration software implementation; and IM for the rollout of the endpoint device management software.

Successfully completed non-production testing of the SQL Server 2022 upgrade for the Tyler Munis ERP system. This testing is a key prerequisite for moving forward with the production upgrade during the March maintenance window.

Assisted Payroll with shared drive cleanup in preparation for migrating content to the SharePoint Payroll site. Final migration is scheduled for March.

AIRPORT

Take-offs and Landings – January brought typical winter flying conditions to the Los Alamos County Airport, with colder temperatures and periodic weather systems contributing to moderate seasonal activity. A total of 275 aircraft operations were

recorded for the month, including 72 flights by Classic Air Medical's helicopter operations. While slightly lower than peak summer months, activity levels remain consistent with winter seasonal trends and continue to reflect steady use by based aircraft and critical aeromedical services.

Updates

In January, the Airport Division hosted a representative from the Federal Aviation Administration (FAA) who conducted on-site aircraft rescue and firefighting (ARFF) training in coordination with the Los Alamos Fire Department. This hands-on training strengthens emergency preparedness and reinforces the airport's commitment to maintaining high safety standards.

The Airport Manager worked with Leslie Bucklin from the County Manager's Office and the FAA to comprehensively update and modernize the County's Drone Policy, clarifying operational guidelines and improving regulatory alignment with evolving FAA unmanned aircraft system requirements.

The Airport Manager also attended professional development training in Dallas through the American Association of Airport Executives (AAAE) Certified Member (CM) program. This continuing education effort supports long-term professional credentialing and ensures airport leadership remains current with national aviation management standards and best practices.

Planning efforts are underway for the 2026 Airport Open House, which has been finalized for September 12th from 9:00 a.m. to 12:00 p.m. The event will be held in collaboration with the Los Alamos Chamber of Commerce and will include a concurrent Home Business Expo, further strengthening ties between the airport and the local business community.

Additionally, a small but engaged group of local pilots and community members continues to meet regarding the potential formation of a flying club. The Airport Division is facilitating space for discussions, supporting community-led aviation initiatives while remaining neutral in the organizational process.

Los Alamos County is working on a variety of projects that support quality of life, infrastructure, and economic development initiatives.

Several facility projects are currently moving forward. Work to install new HVAC units at the Golf Course Pro Shop is underway, while installation of units for the Community Room has been completed. Asbestos abatement began on February 23, 2026, at buildings 112, 124, and 126 along Long View Drive. On February 10, Council approved Task Order 29 with All-Rite Construction LLC to begin improvements at Brewer Arena. In addition, the Invitation for Bids for the Fire Station 4 replacement project was advertised on February 10, with bids closing in mid-March and a contract award expected in April 2026.

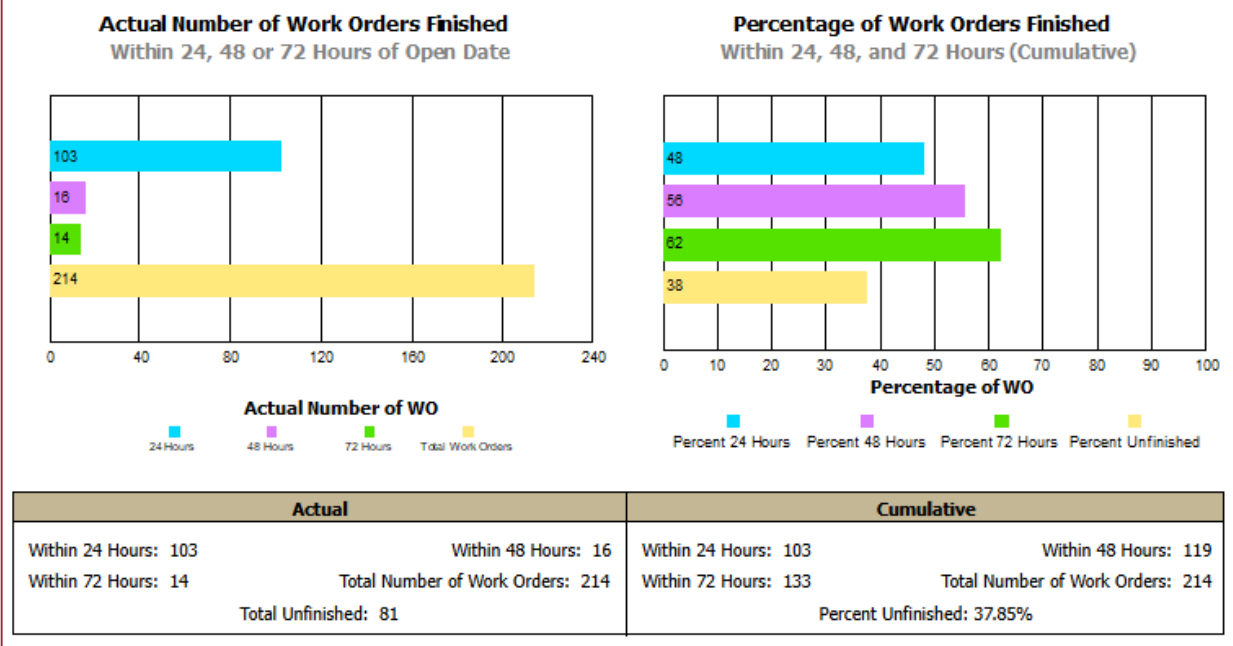

Signs and Markings Division

The Signs and Markings Division has begun installing the new Wayfinding signage. A total of 120 bases were previously installed in 2025, and crews are now completing the sign installation phase. To date, 11 signs have been installed along Central Avenue and Canyon Road.

In addition to wayfinding efforts, the division completed multiple sign repairs and replacements. A total of 19 signs were fabricated and installed to address maintenance needs throughout the county.

Training and Development

The Traffic Safety Specialist has been assigned to provide training for crew members preparing to obtain their Commercial Driver's License (CDL). To date, two employees have successfully completed the written training portion and are scheduled to take the skills (driving) examination in Las Vegas, New Mexico.

Streets Division

Streets crews have been actively engaged in infrastructure maintenance and repair projects. Sidewalk repairs were completed along a trail near Totavi, including curb and gutter repair and replacement at 535 and 585 Totavi Street.

Road maintenance operations are ongoing in Bayo Canyon and Rendija Canyon, where crews are performing roadway repairs to improve surface conditions and safety along this important evacuation route.

Countywide street sweeping operations have continued, along with weed abatement and trash removal to maintain roadway cleanliness and visibility.

Storm Response

Crews responded to two snow events during the reporting period and conducted post-event equipment cleaning and preparation to ensure readiness for subsequent storms. Additionally, personnel patrolled county roads following recent windstorms to identify and remove downed trees and debris, ensuring safe travel conditions.

Projects

Denver Steels Phase II Improvements Project

The project includes replacement of roadway, targeted concrete replacement including curb and gutter, valley gutters, sidewalk, drive pads, and ADA improvements. Aging water lines and fire hydrants will also be replaced.

- The Recruitment team is in the solicitation process for RFP for a new applicant tracking system.

HOUSING

Updates

20th Street Development Solicitation: The due diligence phase of development kicked off on October 10, 2025. County staff and the development partner are reviewing engineering, soils, planning reports, and similar documents. The due diligence earnest money transfer has taken place, and the Title Report and ALTA survey of the property have been revised and completed. The due diligence period is expected to take until April 2026. [Goals: Downtown Revitalization, Local Business, Housing.]

9th Street Apartments: Key developments this quarter include the successful completion of five-unit renovations and the initiation of major electrical infrastructure upgrades across all three buildings. The focus in the first part of 2026 will be completing the electrical upgrades and implementing energy efficient improvements with the installation of mini splits across units. [Goals: Housing.]

Affordable Housing Service Providers: In the coming weeks, the Housing Trust will launch a new round of marketing for the various programs with a DPU billing insert as well as at various events throughout the community. They currently have multiple applications in process for both the Home Rehabilitation and Homebuyers Assistance programs. [Goals: Housing.]

North Mesa Update: Staff from the County and Wilson and Company presented finding of the North Mesa Transportation and Utilities Study at a joint LAPS Board and County Council work session on February 26, 2026. The final report was well received. The

study provides preliminary designs and cost estimates for system upgrades needed to serve the site with utilities and to mitigate the project's impact on the transportation system. [Goals: Housing, Intergovernmental Relations.]

Coyote Mesa (A-8-A): The effective date for the Sales, Purchase, and Development Agreement for the A-8-A property is November 14, 2025. This key date kicks off the due diligence phase of the development process. The due diligence period is expected to be completed in early 2026. During this phase county staff will provide the development team with key documents including previous engineering, soils, planning reports, and similar documents for review. The Title Report and ALTA Survey for the property have been completed. The development partner is finalizing the site survey and geotechnical boring and analysis. Closing on the property is anticipated in early 2026. [Goals: Housing.]

Public Meeting

There was a joint meeting with the Los Alamos Public School Board and County Council on February 26 at 5:30p at Chamisa Elementary in White Rock to learn more about the North Mesa LAPS Transportation and Infrastructure study.

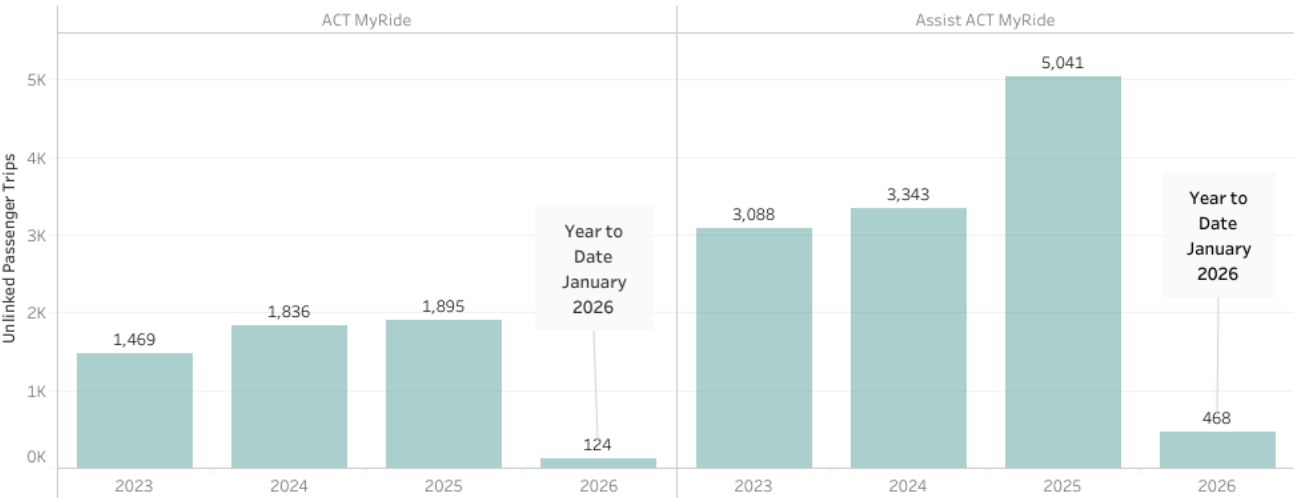

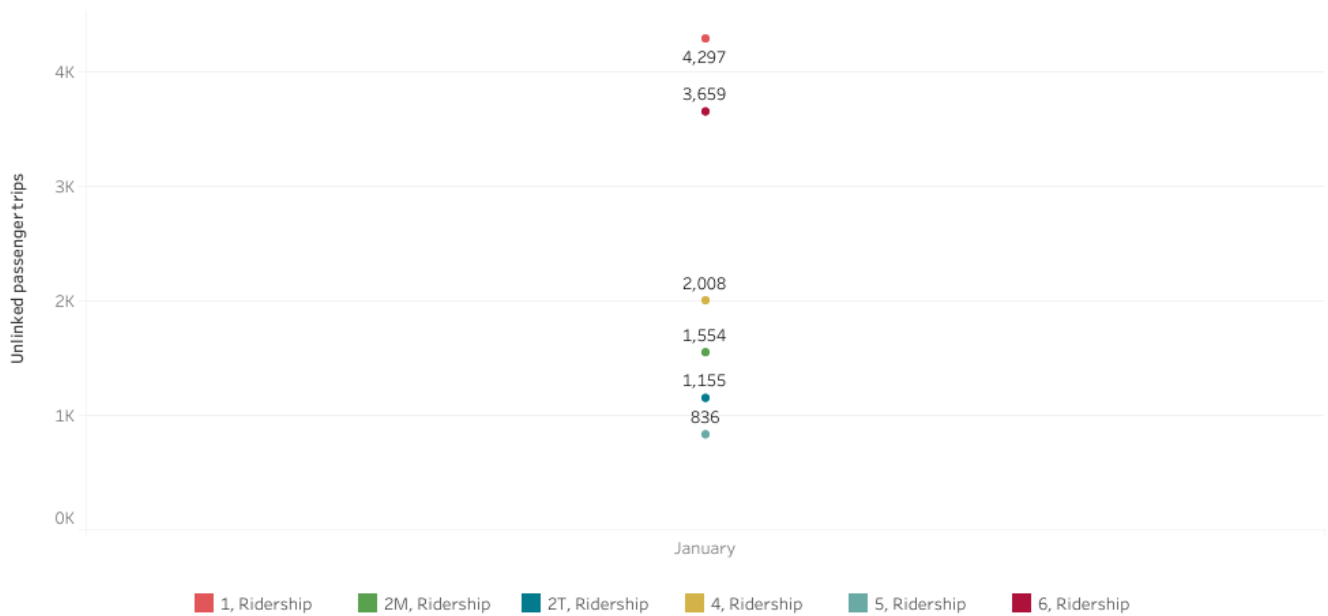

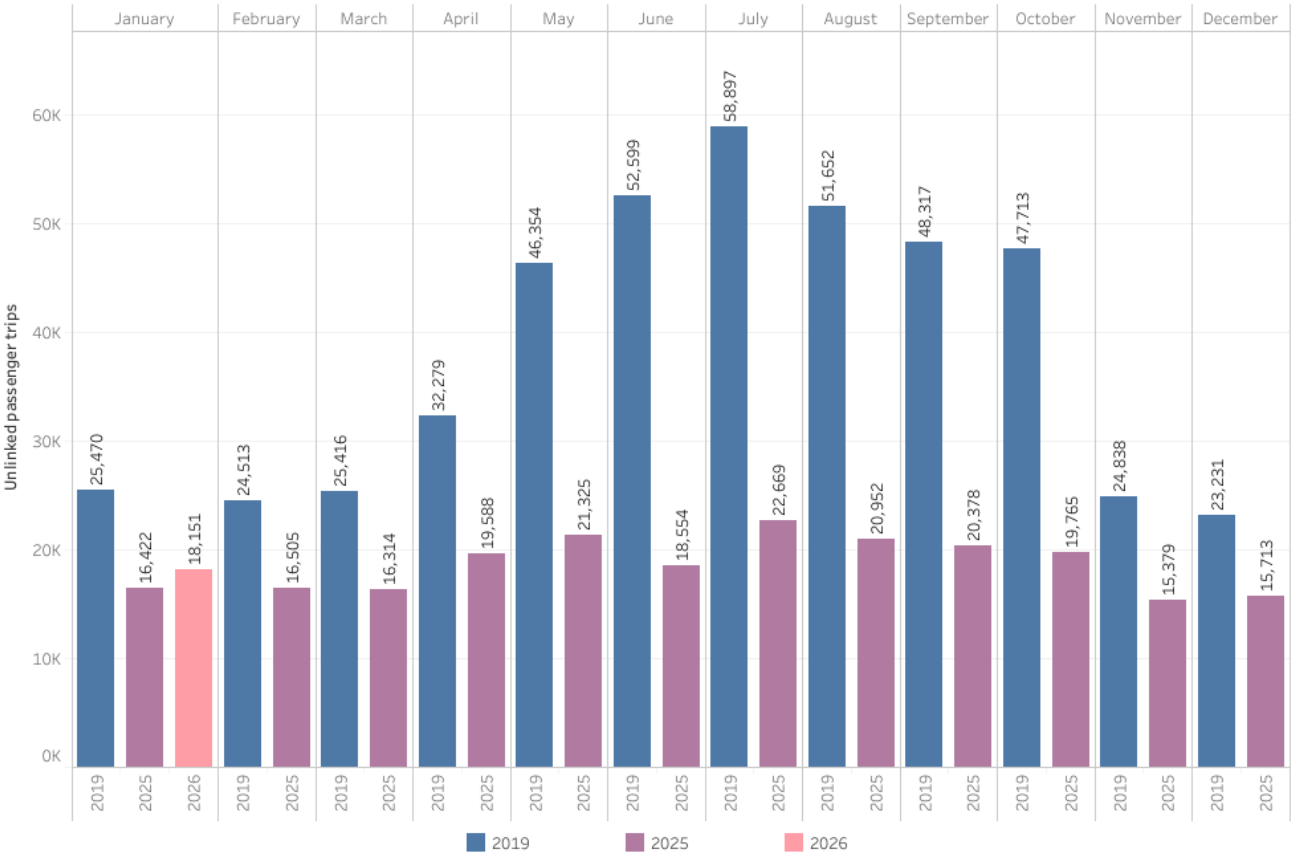

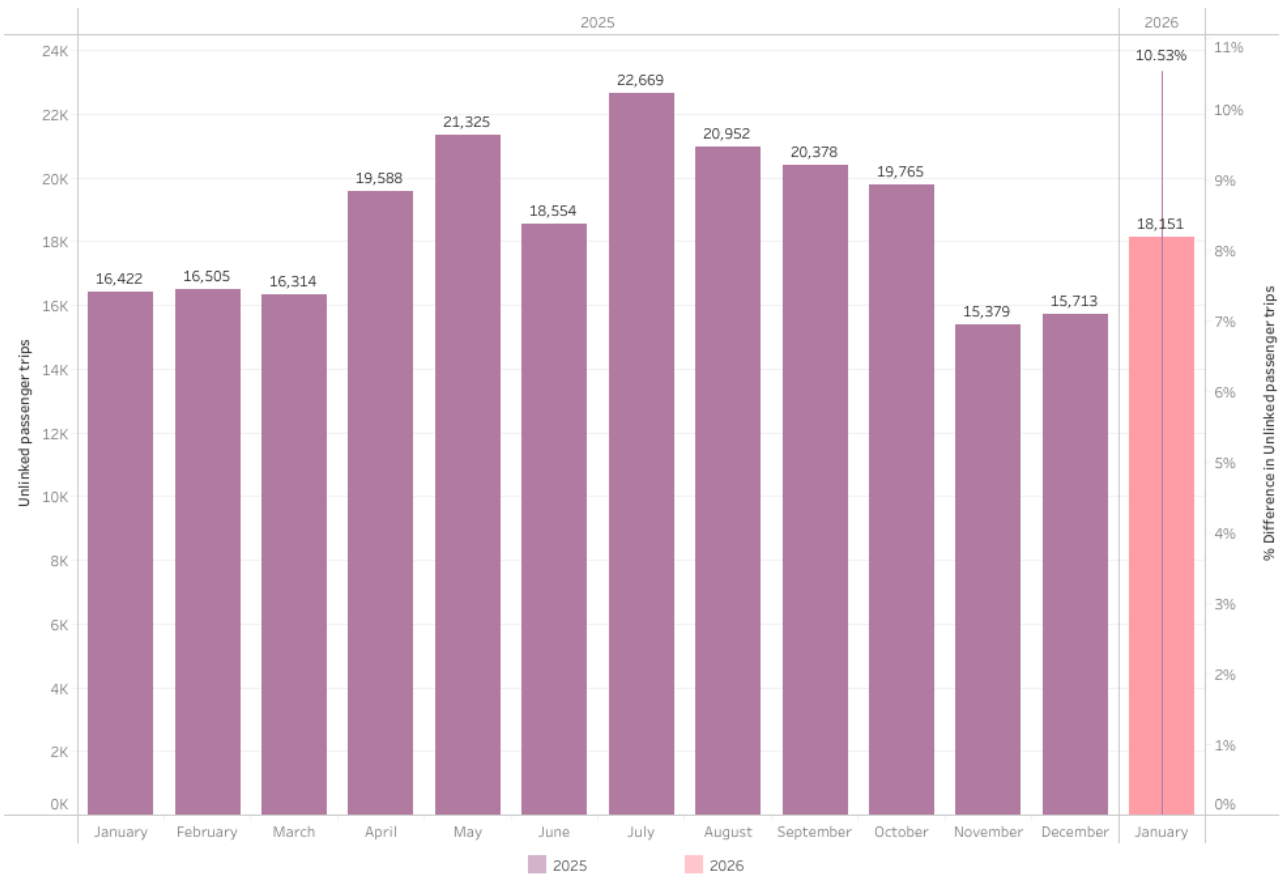

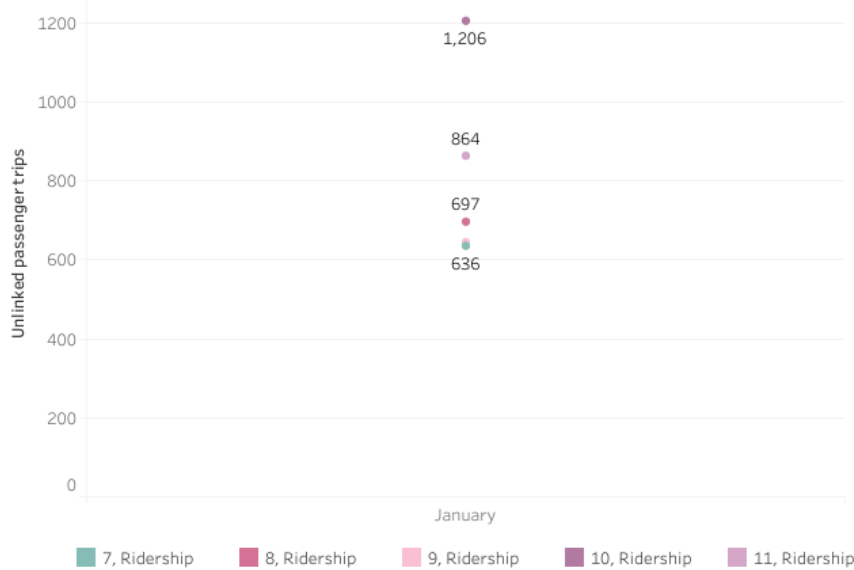

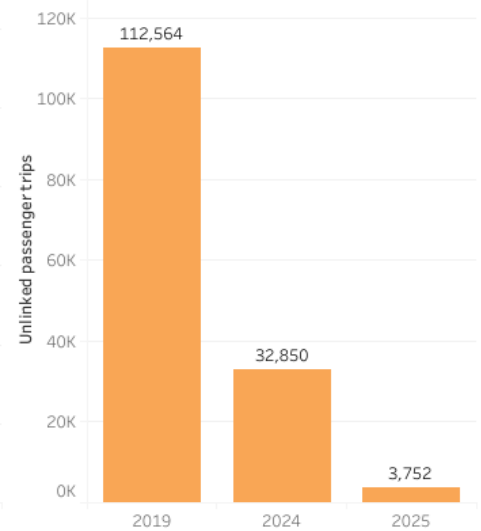

TRANSPORTATION BOARD

The Transportation Board meeting focused on safety improvements along NM 502, where Jennifer Morrow, Senior Engineer, presented plans for installing rumble strips and restriping at Camino Entrada to address crash concerns, including a recent fatality. The board reviewed and approved Attachment A of their work plan, which included various quality of life and infrastructure initiatives.

The meeting also included the welcome of new Council Liaison Councilor Havemann, and farewells to outgoing members Nancy Talley and Michael Altherr. Eric Martinez, Public Works Director provided updates on the county's bronze-level bicycle-friendly community designation, the Denver Steels roadway project, and the installation of a Hawk signal at NM 4.

The board discussed the need for regulations regarding sign placement on public right-of-way and concluded with plans for future discussions on fire hazard preparation due to dry weather conditions.

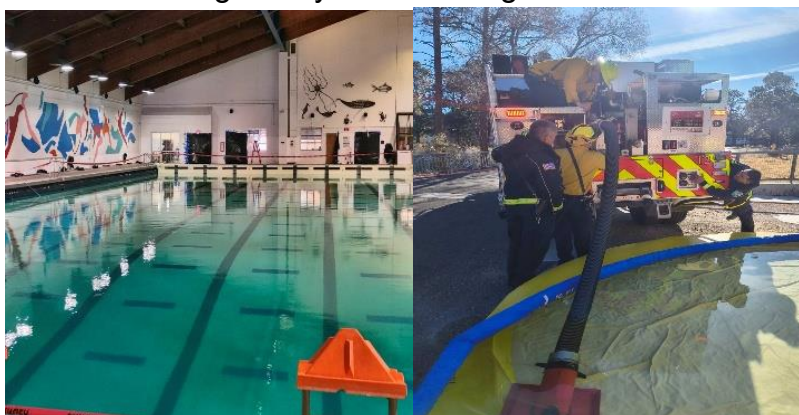

Update

In the month of February, an additional Certificate of Occupancy was issued for The Hill Apartments multifamily project. Currently, roughly 80% of the project has passed final inspections. The contractor is hopeful that the remaining buildings will be ready for final inspections prior to May 1, 2026.

Earlier in the month, Monica Rivera (Permit Technician) and Michael Marquez (Plan Reviewer) met with the Design Professional and Contractor for the Coyote Mesa (A-8-A) project to begin guiding them through the permitting process. This meeting was held to inform them of the documentation required for a permit submittal. During the meeting, the team was also able to highlight common “pitfalls” encountered when submitting permit applications. A pre-application meeting was arranged for March 2 with all departments involved in the plan review process.

Looking Ahead

The next “DIY” meeting with homeowners is scheduled for March 26. This is an excellent opportunity for residents contemplating home improvement projects to meet with staff and get questions answered about the permit application process. The Building Safety and Planning Departments will partner to host this meeting at Fuller Lodge from 9:00 AM to 12:00 PM on the 26th.

Building Safety will also be hosting a contractor meeting on the afternoon of April 10. This meeting is geared towards roofing contractors working in Los Alamos County.

Topics will include common definitions, the permit and plan review process, available resource guides, and common corrections identified during inspections.

The Police Department receives a high volume of Public Information requests. EMS Phoenix Awards

In February, during a regular meeting of the Los Alamos County Council, the Los Alamos Fire Department proudly presented the Phoenix Award — one of the most prestigious honors in Emergency Medical Services.

The Phoenix Award is presented to responders who successfully resuscitate a patient in cardiac arrest and whose patient survives to return home from the hospital with little to no neurological deficit. Named after the mythical phoenix rising from the ashes, the award symbolizes rebirth — a second chance at life.

This incident reflected a perfectly executed chain of survival. Two family members took immediate and heroic action before first responders arrived. Their courage and decisive efforts were instrumental in the patient's outcome, and they were also formally recognized during the ceremony.

Emergency communications played a critical role as well. The calm, professional guidance provided during the 911 call ensured that lifesaving care began immediately and continued seamlessly until the crews arrived on scene. This coordinated effort demonstrated the strength of an integrated emergency response system working exactly as designed.

The team was especially honored to have the patient whose life was saved, along with his wife, join us for the presentation. His presence was a powerful reminder of why training, teamwork, and compassion matter. Seeing him standing alongside those who answered the call reinforced the profound impact of preparedness and swift action.

Environmental Sustainability Board

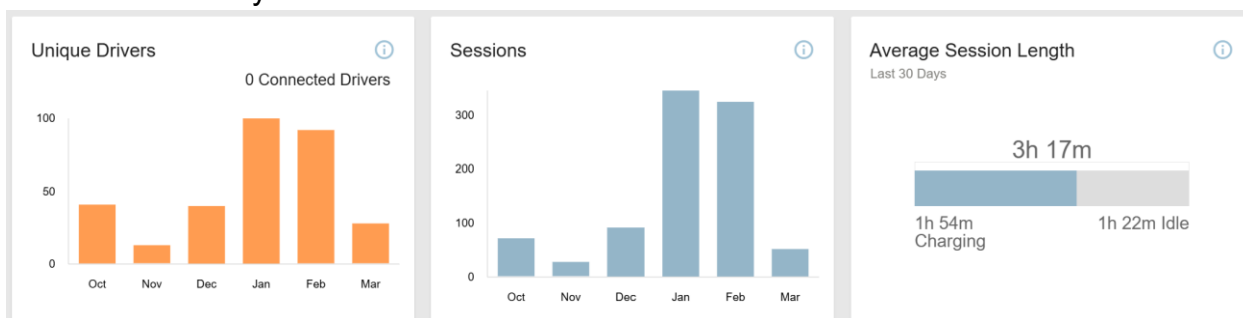

Electric Vehicle

Staff continue to work on the implementation of the 2 Direct Current Fast Chargers at Mesa Public Library. Staff ordered the EV Charging Equipment and have requested a quote for construction services.

The final Fleet Conversion Plan and Community Wide EV Charging Plan will be presented to Council in March.

The 6 new Level 2 chargers at Municipal Building have been operational for two months. Below is the report from January 1 – March 4. GHG savings are 5,445kg for the month of February 2026.

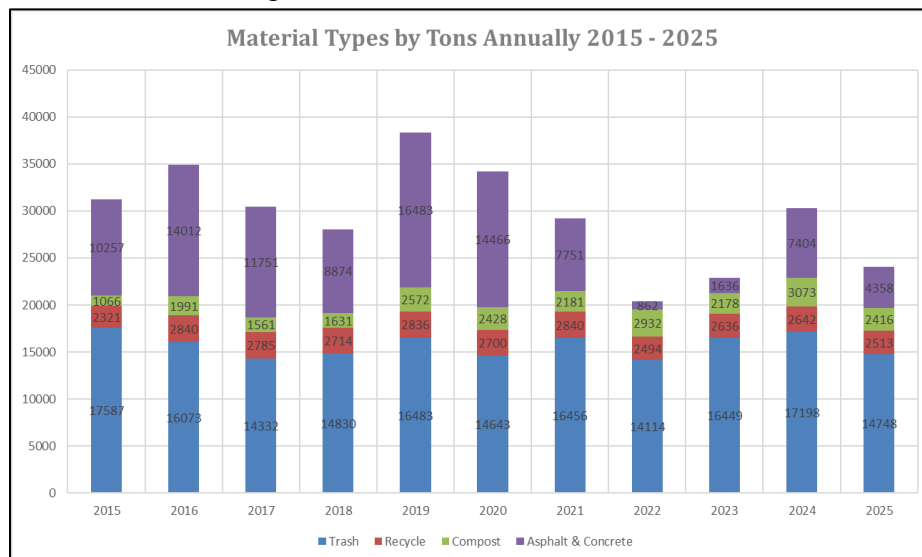

Update

Environmental Services submitted its Annual Report to the New Mexico Environment Department on February 14, 2026, in accordance with state reporting requirements. The report provides a comprehensive summary of operational data and material management outcomes for the 2025 calendar year. In 2025, the total volume of materials disposed of at the landfill decreased by 2,450 tons compared to the previous year. Additionally, volumes across other material streams—including recycling and brush—also declined from 2024 levels, reflecting overall shifts in material intake and disposal patterns during the reporting period.

Environmental Services' contractor, GM Emulsion, has been actively working to crush and process the existing concrete and asphalt stockpile. The material is being crushed and screened to create a reusable aggregate suitable for base course applications in construction and infrastructure projects. Once processing is complete, the finished product is available for purchase directly through GM Emulsion, supporting responsible material management and the beneficial reuse of previously stockpiled materials.

In response to the drier-than-average winter and increased fire danger, Environmental Services is offering an additional service to help residents reduce fire risk. This service includes the collection of large brush piles and bagged yard debris. The expanded service will be available through March 27, 2026.

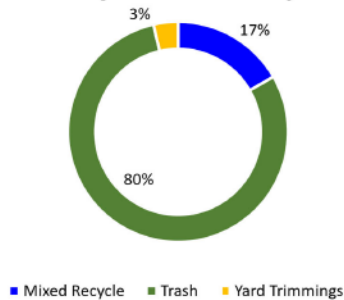

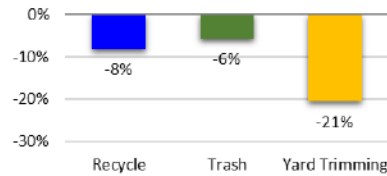

Monthly Collection Report

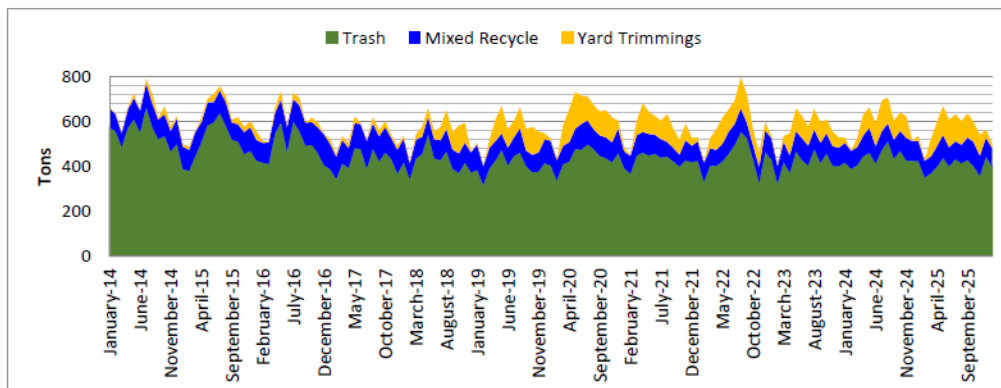

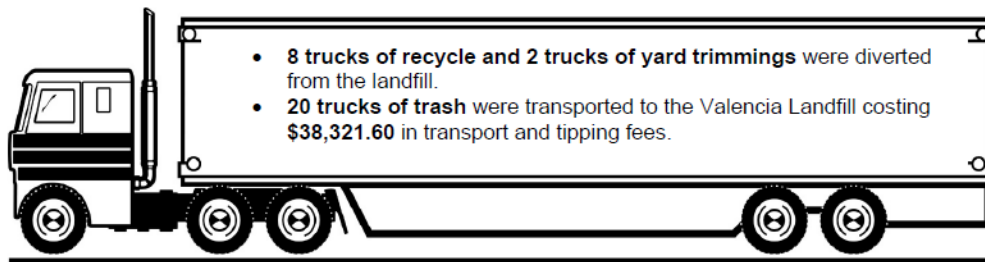

Los Alamos County is working on a variety of projects that support quality of life, infrastructure, and economic development initiatives. A summary of the project and additional information can be found on the website– <https://lacnm.com/PW-Projects>.

ROADS

Updates

Engineers for the Canyon Rim Trail Phase III project began biological assessments required by easements granted from the DOE/NNSA. These assessments will be completed later in the year and are the final step prior to advertising for construction. Evaluation is underway of proposals received for the 2026 pavement condition survey and new pavement asset management software. Once awarded, the pavement condition survey will begin later in the year.

Staff is working to schedule a contractor to begin installation of centerline rumble strips on NM 502 from Airport Road to just east of East Gate Drive. Once the work begins, it should be completed within about two weeks.

Connecting with the Public

The Denver Steels Phase II public outreach process consists of coordination with affected residents, businesses, and Los Alamos Public Schools. This coordination is critical to successful project execution while minimizing negative impacts.

Upcoming project planning is underway for public outreach for the multiple projects being overseen by Public Works including construction of Trinity Drive Safety and ADA, NM-Crossing and Multi-Use Trail; and design of Denver Steels Phase III and Fairway Drive projects.

Looking Ahead

Staff continue to prepare multiple grant applications to help fund CIP and pavement preservation projects in FY27.

Preparation continues in preparing solicitation of bids for several key projects, including the Finch Street project, Trinity Drive Safety and ADA Improvements, and the NM-4 Multi-Use Trail and Crossing.

Design development continues for two Capital Improvements Projects for Denver Steels Phase III and Fairway Drive. These projects are joint-utility projects and are anticipated to be advertised for bids in late 2026 for 2026/2027 construction.

The Engineering Division continues to play an active role in reviewing developer applications, conducting inspections, and approving construction permits and design reviews. Recent reviews have covered a diverse range of projects, such as the Christus

Development, A-8-A near DP Road, 20th Street Development, the Guesthouse Hotel (old Hilltop House site), the Women's Dormitory Building, and the Hills Apartments/35th Street Realignment. Other reviews include the Century Bank, Sherwood Rounds off Longview Drive, Arbolada, and the redevelopment of the Motel 6 building.
